INFORMATION OBLIGATIONS

According to Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter "GDPR"), we inform you that:

- 1. The controller of your personal data is Jagiellonian University, located at 24 Golębia Street, 31-007 Kraków, represented by the Rector.

- 3. Your personal data will be processed for the purpose of considering your application for benefits from the Company Social Benefits Fund, based on:
 - in the case of ordinary data: Article 6(1)(c) of the GDPR legal obligation incumbent upon the controller;
 - in the case of special categories of data: Article 9(2)(b) of the GDPR processing is necessary for the purposes of carrying out the obligations and exercising specific rights of the controller or of the data subject in the field of employment law, social security, and social protection.
- 4. Your personal data will not be disclosed to third parties. The recipients of the data will only be institutions authorized by law.
- 5. Your personal data will not be transferred to third countries or international organizations.
- 6. Your personal data will be stored for no longer than is necessary to fulfill the benefits due to you from the Company Social Benefits Fund, as well as for the period necessary to assert rights or claims. After this period, personal data will be stored to the extent necessary for archival purposes for the period specified by law.
- 7. You have the right to: obtain information about the processing of personal data and the rights conferred by the GDPR, access the content of your data and correct it, as well as the right to have your personal data deleted from the administrator's databases (unless further processing is necessary to fulfill a legal obligation or to establish, assert, or defend legal claims), and the right to restrict processing, data portability, and object to processing in cases and under the conditions specified in the GDPR.
- 8. If you believe that the processing of your personal data violates the provisions of the GDPR, you have the right to lodge a complaint with the President of the Personal Data Protection Office.
- 9. Providing personal data is voluntary but necessary to receive social benefits funded by the Company Social Benefits Fund. The consequence of not providing personal data is the inability to consider your application and grant benefits from the Company Social Benefits Fund.
- 10. Your personal data will not be subject to automated decision-making or profiling.
